SUBJECT: New Bankruptcy Noticing Center (BNC) Certificate of Notice Format

---

Effective Friday, September 6, 2013, the BNC Contractor used by the Court to serve papers will replace the current Certificate of Notice (which we refer to locally as the BNC Certificate of Mailing) with an updated format.

Several years ago, the Court implemented "Reduced Paper Module" (RPM) which caused those who receive papers electronically via CM/ECF to no longer receive a redundant copy via BNC.

At that time, the BNC Certificate of Notice did not list those who received the paper via CM/EC. It only listed those BNC served requiring a review of both the BNC Certificate of Notice and the Notice of Electronic Filing in CM/ECF to determine who the Clerk's office served with a particular paper.

Subsequently, BNC added an additional page(s) to the Certificate of Notice that separately lists those served by CM/ECF, removing the need to look in two places to see all who were served by the Clerk's office with a paper. The new format effective, September 6, further enhances the Certificate of Notice by removing the separate page(s) listing those who received the paper via CM/ECF and adds the CM/ECF recipients to the bottom of the page showing who BNC served.

This electronic signature will have the same force and effect as the contractor representative's handwritten signature and will be treated as the original signature for all purposes. The contractor representative's affidavit and original signature will be kept on file at the Administrative Office.

#3. The NEF recipient information will be placed immediately after the signature.
